

## Official Rules for 2018 HomeAdvantage Sweepstakes

### OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. INTERNET ACCESS IS REQUIRED TO ENTER.

### ELIGIBILITY:

To enter Space Coast Credit Union's (the "Sponsor") 2018 HomeAdvantage Sweepstakes (the "Sweepstakes"), you must be 18 years or older, a U.S. Citizen or legal resident with valid social security number or government issued ID at the time of entry. Employees of Space Coast Credit Union (SCCU), their Board of Directors, Supervisory Committee, their affiliated companies, parent, subsidiaries, service partners, and advertising and promotion agencies (collectively, "Sweepstakes Entities"), and their IRS dependents, immediate families (i.e. parents, children, siblings, spouse) and members of their households (whether related or not) are ineligible to participate in this Sweepstakes. The Promotion is void outside the 50 United States/D.C. and where prohibited.

### HOW TO ENTER:

The Sweepstakes will begin on April 2, 2018 at 12:01 a.m. Eastern Daylight Time and ends June 30, 2018 at 11:59 pm Eastern Daylight Time (the "Sweepstakes Period"). There is one (1) way to enter for the grand prize: register with HomeAdvantage by going to [sccu.com/yourhome](http://sccu.com/yourhome), clicking on the HomeAdvantage Sweepstakes link, and completing the fields with your information. Odds of winning depend upon the total number of eligible entries received. SCCU is not responsible for lost or misdirected entries. By entering the Sweepstakes participants are acknowledging acceptance of these official rules. Limit one (1) entry per person; proxies are not permitted.

### PRIZES:

Prizes: One (1) Grand Prize of one thousand dollars (\$1,000) will be awarded as a check payable in U.S. dollars to the winner. Grand Prize winner is responsible for all federal, state and local taxes, and any other expenses related to acceptance and use of the prize. No prize substitution, except at Sponsor's sole discretion or as otherwise provided herein.

ODDS: The odds of winning will depend upon the total number of eligible entries received.

DRAWING: The Grand Prize will be awarded in a random drawing conducted by SCCU, among all eligible entries received, on or around July 13, 2018.

### NOTIFICATION OF GRAND PRIZE WINNER:

The decisions of the Sponsors are based on their sole discretion and interpretation of these official rules and are final and binding in all respects. The potential Grand Prize winner will be contacted by email and/or phone within ten business days. If a potential winner cannot be reached within ten business days from the first notification attempt, then such person shall be disqualified and an alternate winner will be selected.

### PRIZE CONDITIONS:

Limit one (1) grand prize during the Sweepstakes period. The potential grand prize winner will be required to attend a prize presentation and photo opportunity at their expense within 20 business days from first

notification attempt at a designated Space Coast Credit Union Branch, located within the State of Florida. The potential grand prize winner will execute an affidavit of eligibility, a liability release and a publicity release and other documents including but not limited to tax documents, as applicable, except where prohibited by law. Such documents must be returned by the date and/or time indicated within such documents. If the potential grand prize winner fails to return such documents within that time, or fails to appear at the prize/check presentation, or if a potential prize winner is found to be ineligible, or if he/she does not comply with the Official Rules, then the potential prize winner will be disqualified and an alternate prize winner will be selected through a random drawing by the Sweepstakes Sponsor from the remaining entries. If the prize notification is returned as undeliverable, this will result in disqualification and an alternate winner will be selected.

Potential winner must report income to the Internal Revenue Service (consult a tax advisor). In the event it is deemed during the verification process that potential winner does not have a unique, personal and valid Social Security number for Sponsor to report the tax liability associated with acceptance of the prize, potential winner will be disqualified and another winner selected. Except where prohibited by law, the winner's entry and acceptance of the prize constitutes permission for the Sweepstakes Entities to use said winner's name, photograph, likeness, statements, biographical information and voice on a worldwide basis, and in all forms of media, in perpetuity, without further compensation.

If a winner is a member of SCCU, with accounts that are delinquent or past due, then the amount owed SCCU will be deducted from the Approximate Retail Value of the prize. The remaining dollar value (if any) will be awarded to the member as a check in the amount of prize balance.

This Sweepstakes is subject to all applicable federal, state and local laws. By participating, entrants and their participating entities agree to be bound by these Official Rules and the decisions of the Sponsor and waive any right to claim ambiguity in the Sweepstakes or these Official Rules.
