OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

HOW TO ENTER: Beginning on September 8, 2025, at 8:00 a.m. ET through September 17, 2025, at 11:59 p.m., enter the SCCU Miami Dolphins Jersey Giveaway on social media in one of three ways: On SCCU's Facebook page at facebook.com/flspacecoastcreditunion by completing all three steps: (1) by liking the SCCU Facebook page, (2) by liking the Miami Dolphins Jersey Giveaway post, AND (3) by tagging 1 person in a comment on the Miami Dolphins Jersey Giveaway post; OR on SCCU's LinkedIn page at linkedin.com/company/spacecoastcreditunion/ by completing all three steps: (1) by following the SCCU LinkedIn page, (2) by liking the Miami Dolphins Jersey Giveaway post, AND (3) by tagging 1 person in a comment on the Miami Dolphins Jersey Giveaway post; OR on SCCU's Instagram page at instagram.com/spacecoast_creditunion by completing all three steps: (1) by following the SCCU Instagram page, (2) by liking the Miami Dolphins Jersey Giveaway post, AND (3) by tagging 1 person in a comment on the Miami Dolphins Jersey Giveaway post. You may enter only once, either on Facebook, Instagram, or LinkedIn; no more than one regular entry per person is permitted.
