OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN.

HOW TO ENTER: Beginning on October 12, 2025, at 11:00 a.m. ET through October 16, 2025, at 11:59 p.m., enter the Dolphins Game Day \$100 Giveaway on social media in one of three ways: On SCCU's Facebook page at facebook.com/flspacecoastcreditunion by completing all three (3) steps: like the SCCU Facebook page, like the Dolphins Game Day \$100 Giveaway post, AND tag 1 person in a comment on the Dolphins Game Day \$100 Giveaway post; OR on SCCU's Instagram page at instagram.com/spacecoast_creditunion by completing all three (3) steps: follow the SCCU Instagram page, like the Dolphins Game Day \$100 Giveaway post, AND tag 1 person in a comment on the Dolphins Game Day \$100 Giveaway post; OR on SCCU's LinkedIn page at linkedin.com/company/spacecoastcreditunion/ by completing all three (3) steps: follow the SCCU LinkedIn page, like the Dolphins Game Day \$100 Giveaway post, AND tag 1 person in a comment on the Dolphins Game Day \$100 Giveaway post. You may enter only once, either on Facebook, Instagram, or LinkedIn; no more than one regular entry per person is permitted. One bonus entry is allowed per person by sharing the Dolphins Game Day \$100 Giveaway post in either your Facebook or Instagram stories and tagging the SCCU account. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. 2. ELIGIBILITY: Open to residents of SCCU's 34-county service area. Complete list of service areas can be found on SCCU.com. Valid Florida Government Issued ID required to claim prize. Must be 18 years of age or older as of October 12, 2025. Employees of Space Coast Credit Union ("**Sponsor**"), their affiliates, subsidiaries, and agencies (collectively "**Promotion Parties**"), and members of their immediate family or persons living in the same household are not eligible for this sweepstakes.
