

WATERFORD LAKES BRANCH GRAND OPENING EVENT (10/24/25) 2 UNIVERSAL THEME PARK ANNUAL PASSES GRAND PRIZE SWEEPSTAKES OFFICIAL RULES

Alternate entries must be received by October 23, 2025.
