MIAMI DOLPHINS GENERAL PUBLIC TICKET GIVEAWAY SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **HOW TO ENTER:** Beginning on November 24, 2025, at 12:00 a.m. ET through December 16, 2025, at 11:59 p.m., enter the Miami Dolphins General Public Ticket Giveaway on social media in one of three ways: On SCCU's Facebook page at facebook.com/flspacecoastcreditunion by completing all three (3) steps: Like the SCCU Facebook page, like the Miami Dolphins Giveaway post and tag a fellow Dolphins fan in the comments of the giveaway post; OR on SCCU's Instagram page at instagram.com/spacecoast_creditunion by completing all three (3) steps: Follow the SCCU Instagram page, like the Miami Dolphins Giveaway post and tag a fellow Dolphins fan in the Miami Dolphins Giveaway post comments; OR on SCCU's LinkedIn page LinkedIn.com/company/spacecoastcreditunion/ by completing all three (3) steps: Follow the SCCU LinkedIn page, like the Miami Dolphins Giveaway post and tag a fellow Dolphins fan in the Miami Dolphins Giveaway post comments. You may enter only once either on Facebook, Instagram or LinkedIn. No more than one entry per person is permitted. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification.
