Where's Watchdog Giveaway

OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN.

HOW TO ENTER: Beginning on March 4, 2026, at 11:00 a.m. ET through March 16, 2026, at 11:59 p.m., enter the Where's Watchdog Giveaway on social media in one of two ways: On SCCU's Facebook page at facebook.com/flspacecoastcreditunion by commenting the required emoji on the Where's Watchdog Giveaway post; OR on SCCU's Instagram page at instagram.com/spacecoast_creditunion by commenting the required emoji on the Where's Watchdog Giveaway post. If your comment is randomly selected by SCCU, you will receive a direct message from SCCU and must reply with a screenshot showing the correct location of Watchdog to win the prize. You may enter only once, either on Facebook or Instagram; no more than one regular entry per person is permitted. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.

2. ELIGIBILITY: Open to residents of SCCU's 34-county service area. Complete list of service areas can be found on SCCU.com. Valid Florida Government Issued ID required to claim prize. Must be 18 years of age or older as of March 4, 2026. Employees of Space Coast Credit Union ("**Sponsor**"), their affiliates, subsidiaries, and agencies (collectively "**Promotion Parties**"), and members of their immediate family or persons living in the same household are not eligible for this sweepstakes.
